Dear Congressman Meek,

As a Citizen of the United States, and Constituent from Florida District 17,
And on behalf of "We the People of These United States",

I am asking that you request a Public Congressional Hearing to examine and shed light upon:

The Indisputable evidence revealing an intricate, expanding Radical Islamist Conspiracy to:

- a. Islamize America
